It is my pleasure to present this year Chairmans report for Tararua Sports incorporated, Trading as Upper Hutt City Football.

As we wind down another year, we take this opportunity to reflect on 2019 seasons achievements and changes as well as preparing for a busy 2020.

As a club we aim to provide an environment that creates opportunities for everyone, young and old to enjoy the beautiful game. Whether that be as a spectator, coach, manager or player. This is no mean feat and requires the dedication of group of volunteers to achieve. As with all sporting codes and clubs in a changing world of regulations and requirements, this is getting more difficult to achieve. Volunteers are limited and everyone has a limit on the time they are able to provide. One of the biggest challenges we face as a club is solving this issue.

2019 has been successful year for the men's, women's and junior sections of the club which has been a privilege to watch and participate in. These will be relayed in more detail by our Men's, Women's and Junior Club Captains respectively.

Talent pathways are being introduced in the junior and youth sections of the clubs and Upper Hutt is no different. A club wide strategy, playing and coaching philosophy is being created to ensure the club works together as a whole to provide the best environment for any player to develop to their potential. This will allow for greater collaboration between all sections of the club and will provide a feeder programme to make it easier for players to migrate from youth to senior.

2020 will be a very busy year. We look to go one step further with our men's team, who have been close to Central League play offs for the last couple of years, finishing second this year, they will be hoping to go that one step further next year. The women's team had a very successful year, and will be looking at a spot in the Women's Premier league at the end of next season.

Take into account back to back champions for our Men's seconds and promotions for our Mens Thirds, Fourths and Senior RJ's team we can safely say 2019 has been a very successful season overall for the club.

Due to personal and Business opportunities, I am unable to continue on as Chairman and will be stepping down. I would like to take this opportunity to thank the Executive committee for your work over the past year

#### **Junior Report 2019**

2019 was a successful year for the Junior section of the club, both on and off the field.

Player numbers were high again this year, with over 650 kids playing across the Junior grades. First Kids had 124 registered players which is a great success and continues to provide a base for the club. 7<sup>th</sup> to 17<sup>th</sup> Grades of the club continues to have very strong team representation within the Hutt Valley and wider Wellington leagues. The number of girls playing across the grades remained strong with 91 girls across First Kids to Grade 15. We entered an all-Girl team in the Saturday morning 10<sup>th</sup> grade competition, and had 2 All Girls team attend numerous tournaments throughout the year.

Success on the field takes many forms; participation, enjoyment, development, and particularly for the older kids some victories.

- Our consistently high player numbers are certainly a success. We did lose a few players in the 13<sup>th</sup> & 15<sup>th</sup> age groups due to Schools Competition being introduced for Years 9 & 10.
   Despite this we managed to increase our playing numbers slightly in the year.
- Player enjoyment and development are subjective but the feedback from parents and coaches, plus the volume of smiles at prize giving's would indicate a success year. A visit to the turf on any night of the week during the season will be highlighted by 100's of kids enjoying training and learning new skills.
- Team success varies from team to team but again having attended a few prize giving's it was great to hear of each teams' individual successes. A few team shout-outs for the year:
  - o 7<sup>th</sup> Grade teams winning Wynton Rufer and Wellington United tournaments
  - 9<sup>th</sup> Grade The Taupo team finished 4<sup>th</sup> with a record of W7, 1D, 3L, a great effort for a first time visit to Taupo.
  - 10<sup>th</sup> Grade Wolves an all-Girls team who performed very well in the Saturday morning mixed leagues
  - 11<sup>th</sup> Grade Premier A team won all tournaments entered this year KCU, West's, Douglas Villa and Taupo
  - o 11<sup>th</sup> Grade Girls 'Team Artemis' who won the Petone Invitation tournament.
  - o 12<sup>th</sup> Grade Eagles who finished 3<sup>rd</sup> at the Taupo tournament
  - o 13<sup>th</sup> Grade The A team made the end of season Premier Cup final
  - 13<sup>th</sup> Grade big wraps for the Pumas who had a very difficult first half of the season but hung in there and finished with some well-deserved victories.
  - o 15<sup>th</sup> Grade finish the season on top of Premier C
  - o 17<sup>th</sup> Grade Development Team who finished top of the Premier C league
  - o 11<sup>th</sup> Grade Girls Team Artemis who the Petone Invitation tournament

The Club's success is very much based on the enthusiasm of our volunteers – coaches, managers, match referees and committee members.

A big thanks to all our coaches, managers and referees particularly those who were coerced into the roles. Without your help to teams would not function and games would not go ahead.

On the coaching front we had 28 people complete the Level 1 Coaching course in March, plus another 8 complete their Level 2 & 3 qualifications. This year we have also had a coach attend the Level C course in October. We also had a number of parents attend refereeing course during the year. The club will continue to support the development of the junior coaches and referees.

As in previous years the club's coaches are supported by Pedro Garcias in his role as the Junior Coaching Director. Pedro support of the Junior teams is invaluable and we are very pleased to have Pedro continue in the role next role.

We were very pleased this year to have 3 coaches nominated for the Capital Football Coaches Awards. Congratulations to Glen Mason (9<sup>th</sup> Grade), Scott Wright (9<sup>th</sup> Grade) and Jon Winkworth (13<sup>th</sup> Grade).

Prize Giving underwent a bit of a change this year with the  $9^{th} - 17^{th}$  Grades moving to a night each at the clubrooms rather than grouped at the Heretuanga Cristian Centre. This evening appeared to be very successful with very positive feedback. We will look to do the same again next year. Congratulations to all prize winners, particularly to Lucy Gray ( $13^{th}$  Grade) who was this recipient of the Lennie Scholar.

## 2020

The year ahead will see some changes in the Junior section of the club. Capital Football have ceased their centralized Talent Development Program (TDP) and passed the responsibility to the clubs to run. We have applied to Capital Football for a TDP license and will look to engage Kaizen run the program for us in 2020. Part of this engagement will be to involve some of our 'C' & '3' Level coaches to continue their development, and help build the capability within the club to run the TDP ourselves.

Looking forward to another great year in 2020.

It has been a successful year both on and off the pitch for our senior men's football teams; from top to bottom, with promotions and league titles being picked up throughout. We also welcomed the 'Tararuas', a new 4th team into the competitive pyramid helping us to have more senior registered players than ever before.

I have thoroughly enjoyed my role as senior men's club captain this year. Being able to give back to the club in a small way after enjoying so many personal successful years is something I do not take for granted. Coming into my 19th year in orange I would like to continue to build new relationships and provide a bridge between players and the club off the pitch, with the hope of more success from all our senior teams on it.

#### Women's Report

#### Senior Women

The 2019 season started out on a bit of a low with a large number of players leaving the club for a variety of reasons. There was uncertainty around coaching staff as well as the ability to have enough players to field a team and the tough decision was made to withdraw the UHCF W League team. However, once the decision was made, the women's and girls subcommittee (with the support of the Executive Committee) only looked forward with a continued commitment to support and grow women's football at UHCF. Pedro Garcias was secured as the women's coach and players were recruited - bringing together former UHCF players, new players to the sport, and current players new to the area or searching for a different club. This new team was entered into Division 3 and went from strength to strength as the group of players became a team and the goals piled up. Topping the table in the first half of the season, the team secured promotion to Division 2 and were ready for the challenge the higher division would present. Staying in the top of the table in the second half of the season, the decider for the top spot in Division 2 came down to the last regular game of the season. Tied on points and only 1 away on goal difference from North Wellington, the game was played in Johnsonville in horribly rainy weather but the Parapine ITM UHCF Women's team shone through the rain to secure the win and be presented with the Division 2 winners trophy by former UHCF player, Sarah Gregorious. In addition to the regular season games, the team found success during the Executive Plate knock out competition, advancing all the way through to the final against a Division 1 Island Bay team at Wakefield Park. Unfortunately, the UHCF team was unable to come away with the win that time, but the game gave some great insight as to what to expect for the 2020 season in Division 1.

#### **U18s**

A committed group of returning female youth players and the formation of a new U18s league by Capital Football saw UHCF keen to continue our U18s programme in the 2019 season. Unfortunately, Capital Football was only able to secure 4 teams for the league with several defaults being recorded by other clubs throughout the season. Additionally, the chosen format was 9-a-side on a shortened pitch, which presented some complications and disappointment. Unanticipated inconsistency with the coaching in 2019 also presented a bit of a struggle during the season. However, our UHCF girls remained committed and positive – attending training and games, with some having the opportunity to play up on the senior women's team – and the team really gelled during the season, helped along with great support from the team manager. After being top of the table for most of the season, the team finished second in the league and is looking to see what will happen with the U18s league for the 2020 season.

Thanks to all of our supporters during the season – committee members, refs, coaches, bar/kitchen staff, and our fans who came and cheered us on. Go Orange!

- The loss included a Fixed Asset write off of \$26,082. Without this adjustment a profit of \$18,849 would have been recorded

Trading income of \$329,398 is in line with 2018 was down slightly on prior year, was driven by

Operating costs of \$42,359 included the Fixed Asset write off \$26,082. Adjusted for that item costs were \$17,433 which is in line with prior years

The Fixed Asset write off relates to assets brought into Xero in October 2015 at the value of \$26,082 and not depreciation since. It is believed the asset is the Deck/Balcony added on to the clubroom. Whilst the balcony would be treated as building Improvements, as the Club do not owe the clubrooms it should not be considered an asset of club.

There is a further accounts held with BNZ under the account name of 'Upper Hutt Girls Football Development Squad. This accounts were set up back in 2011 to help facilitate fundraising for Female tournaments. Several fundraisings companies, such as the on-selling of Chocolates (required a user-level account), Lifebooks (required a user-level account) and Domino's pizza (allocate a cheque to an individual's name), required an account that matched details of the person registered as responsible

for the fundraiser. At the time, the club was unable to facilitate the collection of funds directly for the examples provided.

Invoices related to girl's football tournaments are billed to the club, and either paid direct from this accounts, or paid from the Club accounts and reimbursed from these accounts.

The balance of these accounts are currently \$xxxx

At the present time these accounts are outside of the clubs accounting system Xero, and as such are not reported in the P&L, CashFlow and Balance Sheets provided. Kirsty Windleburn (Girls Junior Development Officer) and Kate Pettengell (Women's Captian) have now became a signatories of the accounts and we will discuss on-going management of this account in the 2020 year.

## **Balance Sheet**

The Net Assets of the club decreased by (\$7,233) in the year. The increase in Cash at Bank of \$32,017 was offset by lower Accounts Receivable and the write down in Fixed Assets. Liabilities have increased with Accounts Payment at \$10,849 at Year End, offset marginally by a high GST Refund owing.
